Sealed bids for a lump sum subcontract are invited from prequalified ELECTRICAL subcontractors (hereinafter "Subcontractors") for the following work:

UCLA MID-WILSHIRE MEDICAL OFFICE BUILDING SEISMIC AND PROGRAM IMPROVEMENTS Project Number 908736.01 Bid Package 026A – ELECTRICAL

DESCRIPTION OF WORK:

General Description: The 5 story Medical Office Building (MOB) is located at 5901 West Olympic Boulevard, approximately 6 miles east of the UCLA Campus and is approximately 95,607 GSF. The proposed project would include seismic improvements on all floor levels and interior tenant improvements of approximately 34,000 GSF of space on floors 1-3. The MOB has a current Seismic Performance Rating of V. Upon completion of the work, the MOB would achieve a Seismic Performance Rating of IV or better and bring the facility into compliance with the UC Seismic Safety Policy.

The proposed seismic work will include the installation of approximately 34 seismic dampers placed at specified locations on the inside perimeter of the building's exterior walls. The dampers will be installed diagonally and attached at the bottom and top of the existing steel column bays requiring incidental fireproofing at beam and column modifications. Steel reinforcing plates will be added to existing steel beams and columns to support the installation of seismic damper brackets. Additional seismic reinforcing is required at the existing rooftop mechanical penthouse and at the building foundation at locations along the 1st floor seismic dampers.

In addition to the seismic work, work would also include partial restoration of interior building finishes impacted by the installation of the seismic braces. Limited MEP investigation and safe-off work is anticipated. Site and building accessibility improvements would include path of travel upgrades along the city sidewalk and building entrance, installation of new ADA handrails and guardrails at existing interior stairs. New accessible signage, restrooms and a drinking fountain are also anticipated.

The University has bid and awarded a CM at Risk Contract to Swinerton Builders (hereafter "CM/Contractor"). CM/Contractor is responsible for bidding and awarding all subsequent subcontractor packages, including this package. The successful Subcontractor Bidder shall sign a Subcontract Agreement directly with CM/Contractor and shall be bound by all the terms of the contract between University and CM/Contractor. Refer to Exhibit G – Prime Contract which contains the contract between University and CM/Contractor, attached to the subcontract bidding documents and incorporated by this reference.

<u>Bid Package 026A – ELECTRICAL (this contract):</u> This Bid Package consists of demolition of vacated tenant space in Level 1 of the medical office building, some areas of the exterior landscape, and limited corridor spaces on levels 2 and 3. The demolition work includes removal and disposal of existing lights, power, and low voltage devices, wires, conduits, outlet boxes, j-boxes, and circuits all the way back to the existing power sources in electrical closets and rooms. The main branch panelboards and emergency transformer are to be replaced with a new rating. The rest of the existing electrical infrastructure is to remain. New electrical provisions are to be provided for university program spaces and building support rooms. New electrical connections will be made for new lighting and technology equipment in addition to any required mechanical and plumbing systems.

To support the updated building layout, the proposed low voltage and technology work includes installation of card readers, access control hardware, and video surveillance for building security,

installation of data outlets, wireless access points, phones, control panels, av equipment, ALS antennas, junction boxes, and cable tray for the building's technology infrastructure, provision of (3) 4" underground/below slab conduits from existing carrier yault to new MPOE room, vertical cable tray riser from level 1 to 5, and buildout of new MDF and MPOE rooms. All interconnections between telecom and data rooms to security and technology fixtures are included. Ligature resistant requirements are anticipated for finish products in behavioral health areas.

The anticipated fire alarm work is a deferred approval submittal and involves modification of the existing fire alarm system to provide a fully operational and code compliant system throughout the project area of work and public spaces on levels 1 to 3, including new fire alarm devices as required. Anticipated fire alarm devices include new addressable input modules for supervising automatic sprinkler system waterflow and tamper switches, smoke detectors and addressable control modules for smoke containment, and fire alarm annunciators. Existing fire alarm system components, including fire alarm control panel and remote power supplies, are to remain in place. The fire alarm system shall be designed and installed in accordance with CBC 2022, NFPA 72. and UCLA Design Standards, All equipment shall be UL listed and/or FM approved, including a current California State Fire Marshal Listing. Upon completion of the installation, a satisfactory test in accordance with NFPA 72 shall be made in the presence of the AHJ and signed approval shall be obtained from the AHJ. The existing fire alarm system will need to remain operable to the greatest extent possible. If systems are disconnected for a period of time, interim life safety measures will need to be taken to maintain protection throughout the building and will need to be coordinated with the owner and UCLA CFM.

The estimated construction cost of this bid package is \$5,700,000.

No contractor or subcontractor, regardless of tier, may be listed on a Bid for, or engage in the performance of, any portion of this project, unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5 and 1771.1.

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

The successful Bidder shall pay all persons providing construction services and/or any labor on site, including any University location, no less than the UC Fair Wage (defined as \$15 per hour) and shall comply with all applicable federal, state and local working condition requirements.
