Subject to conditions prescribed by the University of California, Los Angeles, responses to the University's prequalification documents for a CM at Risk contract are sought from prospective CM/Contractor bidders (hereafter "bidders") for the following project:

Cogeneration Plant Cooling Tower Basin Waterproofing Repair

**PREQUALIFICATION OF PROSPECTIVE BIDDERS:** The University has determined that bidders who submit bids on this project must be prequalified. Prequalified bidders will be required to have the following California contractor's license(s):

B License (General Building)

**GENERAL DESCRIPTION OF WORK:** Contractor shall provide waterproofing of the UCLA Cogeneration plant cooling tower concrete basins located on the Facilities Management building roof. The rooftop basins collect water from cooling towers to feed chillers that supply cooling water for campus HVAC equipment. As a part of maintenance programs, the concrete basins need a new waterproofing membrane. To comply with campus cooling need the project is intended to take place in up to (3) construction phases during the winter months where (4) concrete basins of varying sizes will need to be prepped and waterproofed.

The timing of shutdowns is critical. Sequencing of the four tower closures and work to be done is necessary to maintain campus operations with minimal loads to the COGEN Plant.

The CM/Contractor and the University will explore alternate phasing options during Pre-Construction services.

Estimated Construction Cost: \$2,800,000.00

Participants must arrive at or before the above-specified time. Persons arriving later than said time will not be allowed to submit prequalification documents or submit bids as prime contractors. **NOTE:** Bidders who successfully prequalified during the first and second prequalification solicitation for this project remain prequalified and are not required to submit any further documentation. Refer to the UCLA Online Planroom website for a list of said prequalified entities.

**NOTE:** Only hard copy submittals or submittals uploaded to the UCLA Planroom website will be accepted. Oral, telephonic, electronic mail (e-mail), facsimile, or telegraphic Prequalification Questionnaires are invalid and will not be accepted. Only University's Prequalification Questionnaire (and associated documents) will be accepted. University reserves the right (but is not obligated) to request, receive, and evaluate supplemental information after the above time and date at its sole determination.

Any person or entity not satisfied with the outcome of the prequalification must file a writ challenging the outcome within 10 calendar days from the date of the University's written notice regarding prequalification determination. Any assertion that the outcome of the prequalification process was improper will not be a ground for a bid protest.

The dates, times, and location set for receiving and opening of bids will be set forth in an Advertisement for Bids.

The University reserves the right to reject any or all responses to Prequalification Questionnaires and to waive non-material irregularities in any response received.

All information submitted for prequalification evaluation will be considered official information acquired in confidence, and the University will maintain its confidentiality to the extent permitted by law.

Every effort will be made to ensure that all persons have equal access to contracts and other business opportunities with the University within the limits imposed by law or University policy. Each Bidder may be required to show evidence of its equal employment opportunity policy. The successful Bidder and its subcontractors will be required to follow the nondiscrimination requirements set forth in the Bidding Documents and to pay prevailing wage at the location of the work.

In addition, the University is committed to promoting and increasing participation of small business enterprises (SBEs) and disabled veteran business enterprises (DVBES) relating to all goods and services covered under the awarded agreement, subject to any and all applicable obligations under state and federal law, and University policies. The awarded contractor shall make best efforts to provide qualified SBEs and DVBES with the maximum opportunity to participate. The work described in the contract is a public work subject to section 1771 of the California Labor Code.

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

The successful Prequalified Bidder shall pay all persons providing construction services and/or any labor on site, including any University location, no less than the UC Fair Wage (defined as \$15 per hour) and shall comply with all applicable federal, state and local working condition requirements.
